
## Progress Works of CS5/MOWRAM Feasibility Study and Detail Engineering Design

27 January 2023

#### The overall of 27 irrigation subprojects in MOWRAM

- Target: 27 irrigation subprojects located in 4 provinces as : Kampot, Tboung Khmum, Kampong Cham and Takeo.
  - 1. Kampot = 05 irrigation subprojects
  - 2. Tboung Khmum = 07 irrigation subprojects
  - 3. Kampong Cham = 05 irrigation subprojects
  - 4. Takeo = 10 irrigation subprojects
- The 27 schemes divided into 3 Batch (15,107 ha)
  - 1. Batch I= 09 subprojects(3,250 ha)2. Batch II= 10 subprojects(7,095 ha)3. Batch III= 08 subprojects(4,762 ha)
- The detail of 27 irrigation subprojects progress works has descripted the next slides.
